- E. We are just about done getting all of our wildland certification updated in the state computer system with supporting documentation.
- G. Our firefighters that failed their state written are retesting Oct 4, 2023 and then the State is also offering a firefighter 1 state practical at our facility open to other departments on October 21, 2023 with this we have completed our live fire consent form that will be filled out by all firefighters doing live fire with us
  - H. Working on developing a culture of respect around here with our members.

- D. Chief Contract- Discussion on the need for a 3 year contract for the Chief with an appropriate salary. Further discussion to take place at the October meeting.
- E. Board Financial Reports- Discussion on what is needed at the board meeting to review Financial reports.
- F. Spending Limits- Board discussion on increasing the spending limit to \$10,000.00. Ann Grothe made a motion to increase the spending limit to \$10,000.00 and amend the policy to reflect this increase and seconded Susan Borgardt. Roll Call: Susan Borgardt, Beth Burtch, Ann Grothe, Cindy McArthur. All yes, no nays. Motion carried.
