- 4. The Chief met with the DFPC District Chief about the Badger Creek fire. DFPC will cover all mutual aid costs for this fire. She was very happy with how we handled the fire.
- 5. We are in the process of building a new website.
- 6. We were awarded the DFPC Fire fighters Disease and Prevention Grant. The Helmets, Structure boots, Hoods and gloves have been ordered that grant total was \$19,835.00.
- 7. We are still waiting on the AFG grant for our new radios and also the SAFER Grant
- 8. All but 1 of our firefighters now have their wildland Red Card!
