The Hands on Training I did was fire tactics for limited staffing, this was an all day live burn event that was very useful for our departments needs, I also did a hands on training called heavy extrication. This class was about lifting semis' and school buses off of passenger cars and cutting the driver out of a wrecked semi. I sat in on great speakers and then took some great classroom sessions. Must have policies and practices for every fire dept, Drilling For Function, Leading through Training, Step Up and Lead: Leadership skills. I would like to take 3 guys with me next year.
- E. We did our first live burn in the burn facility Thursday. It went great.
- F. Fire Academy is going great! We did a live burn last Saturday. Had 7 instructors teaching this last week
- G. The website went live yesterday! Still working on our email
- H. Elk Creek Fire donated 12 SCBA's to HFPD Lake George an extension ladder, and platte Canyon and extension ladder.
