Chiefs Report:

- 1. Calls to Date in 2023 were 142 and 2024 is 111.
- 2. Impact fee in 2023 was 17 and 2024 is 7.
- 3. Both of the new brush trucks are in service and 1 is available nationally for the wildland season.

- 4. Our 2024 Wildland Field Day is Completed and all our members have their red cards
- 5. Park County Dispatch will be 24-hour operational starting June 1, 2024
- 6. Park County Sheriff's will start staffing from 06:00 to 02:00 Starting June 2, 2024
- 7. We will be doing a Firefighter 2 Academy in September
- 8. We have built a new training program for Exterior and then interior firefighters that will meet the requirements of firefighter 1 and plan to do it next spring.
- 9. In collaboration with HFPD Auxiliary, we are starting a community outreach pancake breakfast. The first one will be May 11 th and will be home safety, June 8th Wildland Preparedness, July 13th Home Mitigation, August 10 th Community Risk Reduction, and September 14th Winter Preparedness.
